In this process ability of the advocate to interview, counsel, and support a client through their legal issue play an important role. The School of Law, IMS Unison University is proud to conduct the National Client Counselling Competition 2021. The objective behind conducting this competition is to let law aspirants test their skills as counsels in terms of handling clients, responding to critical situations, maintaining patience and perseverance, identification as well as approaches to the legal issues faced by the clients. It will inculcate in the students the art of interviewing, planning, and analytical skills that are required for a successful lawyer- client relationship in the law office. Interviewing and advising is a significant part of most lawyers' work. Participants conduct an initial interview with a person playing the role of the client and then address both the client's legal and non-legal needs. Students are called on to explain various aspects of the attorney-client relationship, build rapport, determine client goals, and consider applicable law and options that may be available to the client.

Mode of the Competition: Online (Microsoft teams)

Language: English

Eligibility: Students of three year and five-year law degree courses from any University/Law School/College/Department are eligible to apply for registration of their team.

Team Composition: Each team shall consist of two persons.

Multiple teams are allowed from different University/Law School/College/Departments.

REGISTRATION DETAILS

- ★ The registration fee shall be Rs. 200/- for each team. The registration fee shall be non-refundable and non-transferable.
- ★ The last date for registration is 20th September 2021.
- ★ Teams can register by filing up the google form, which is given below:

- ★ Only 14 teams will be allowed to register in the competition on first come-first serve basis.
- ★ Once a team registers by completing all the formalities, a Code shall be assigned to the team (hereinafter “Team Code”).
- ★ Teams can register for the competition either through official channel of their institute or as independent participation.

ROUNDS:

There shall be three online rounds of this competition. All the rounds will be conducted on Microsoft Teams.

- ✦ **Knock out Round** - According to the scores, the top 4 teams will move to the semi-final rounds.
- ✦ **Semi Final** - Top 4 teams which qualifies the knockout round shall compete against each other and out of which 2 teams shall be carried forward to the final round.
- ✦ **Final Round** - Top 2 teams from Semi-Final Round shall compete against each other and the winner and the runners up shall be declared from them.

DURATION OF ROUNDS:

- ✦ **Knock Out Rounds** - The teams will go through a 25-minute session in the knockout Rounds.
 - Consultation Session of 15 Minutes
 - Discussion Session of 5 Minutes
 - Post-Consultation Session of 5 Minutes.
- ✦ **Semi Final** - Qualified teams will go through a 35-minute Session in the Semi - Final round. The session will include-
 - Consultation Session of 20 Minutes
 - Discussion Session of 10 Minutes
 - and a Post-Consultation Session of 5 Minutes.
- ✦ **Final Round** - Top 2 qualified teams will go through a 50-minute Session in the Final round. The session will include-
 - Consultation Session of 30 Minutes,
 - Discussion Session of 15 Minutes,
 - and a Post-Consultation Session of 5 Minutes.
