**Powers and Functions:**

- To ensure that IMS Unison University Campus remains ragging-free.
- To publicize directives and actions that may be taken against those indulging in ragging.
- To consider the complaints received from the students and order an enquiry, based on which punishment shall be given to the offenders.
- To form anti-ragging squads to make surprise visits and take effective steps to prevent ragging.
- To oversee the procedure of obtaining of undertaking from students in accordance with the provisions.
- To organize workshops against the ragging menace and orient the students.
- To ensure that the telephonic contacts of the persons identified to receive complaints/distress calls are made known to all students.
- To offer services of counseling and create awareness amongst the students.
- To take all necessary measures for prevention of ragging inside the campus and hostels.
