"भारत का संविधान" के अनुच्छेद 200 के अधीन महामिहम राज्यपाल ने उत्तराखण्ड विधान सभा द्वारा पारित 'आई एम एस यूनिसन विश्वविद्यालय विधेयक, 2012' पर दिनांक 13 फरवरी, 2013 को अनुमित प्रदान की और वह उत्तराखण्ड का अधिनियम संख्या 13 वर्ष, 2013 के रूप में सर्व—साधारण को सूचनार्थ इस अधिसूचना द्वारा प्रकाशित किया जाता है।

परन्तु यह कि उपघारा (1) के अधीन कोई अधिसूचना या आदेश इस अधिनियम के प्रारम्म से तीन वर्ष की अवधि की समाप्ति के पश्चात नहीं दिया जायेगा।

(2) उपघारा (1) के अधीन दिया गया प्रत्येक आदेश, यथाशीघ्र राज्य विधान सभा के समक्ष रखा जायेगा।

In pursuance of the provisions of Clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of 'The IMS Unison University Act, 2012' (Adhiniyam Sankhya 13 of 2013).

As Passed by the Uttarakhand Legislative Assembly and assented to by the Governor on 13 February, 2013.

#### THE IMS UNISON UNIVERSITY ACT, 2012 [UTTARAKHAND ACT NO. 13 OF 2013]

#### AN ACT

to establish and incorporate a Private University in the name of "IMS UNISON UNIVERSITY" at Dehradun, Uttarakhand promoted by Institute of Management Studies (Society) registered under The Society Registration Act, 1860 at Dehradun, Uttarakhand to provide and facilitate education, training and research in the areas of Technical education, Higher education, Medical and Dental education, Legal education, Aviation education, Social Sciences, General Sciences and other areas of education.

It is hereby enacted by Uttarakhand State Legislature in the Sixty-third Year of the Republic of India as follows:

# CHAPTER-1 Preliminary

- Short title and Commencement
- (1) This Act may be called the "IMS UNISON UNIVERSITY" Act, 2012.
  - (2) It shall be deemed to have come into force on the date, the notification is issued by State Government in the Official Gazette.

#### Definitions

- 2. In this Act, unless the context otherwise required:-
  - (a) "Academic Council" means the Academic Council of the University;
  - (b) "Authorities" means Authorities of the University:
  - (c) "Board of Governors" means the Board of Governors of the University;
  - (d) "Board of Management" means the Board of Management of the University;
  - (e) "Board of Studies" means the Board of Studies of the University;
  - (f) "Board of Examinations" means Board of Examinations of the University;
  - (g) "Chancellor", "Vice Chancellor", "Pro Vice Chancellor", "Registrar", "Controller of Examinations", and "Finance Officer" respectively means the "Chancellor", "Vice Chancellor", "Pro Vice Chancellor", "Registrar", "Controller of Examinations", and "Finance Officer" of the University;
  - (h) "Campus" means the campus of the University;
